8 SYNOPSIS: This bill would prohibit the operation of a 9 personal motor vehicle with two other personal 10 motor vehicles attached to the first motor vehicle, 11 and would provide penalties.

Amendment 621 of the Constitution of Alabama 12 13 of 1901, now appearing as Section 111.05 of the 14 Official Recompilation of the Constitution of 15 Alabama of 1901, as amended, prohibits a general 16 law whose purpose or effect would be to require a 17 new or increased expenditure of local funds from becoming effective with regard to a local 18 19 governmental entity without enactment by a 2/3 vote 20 unless: it comes within one of a number of 21 specified exceptions; it is approved by the 22 affected entity; or the Legislature appropriates 23 funds, or provides a local source of revenue, to 24 the entity for the purpose.

The purpose or effect of this bill would be to require a new or increased expenditure of local funds within the meaning of the amendment. However,
