2 ENROLLED, An Act,

To alter, rearrange, and extend the boundary lines and corporate limits of the City of Bay Minette in Baldwin County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the City of Bay Minette in Baldwin County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

PARCEL 1

From the Northwest corner of Section 16, Township 3 South, Range 3 East, run South 00° 14' East 1407.3 feet along the section line; thence run East 113.6 feet to the Point of Beginning; thence run North 01° 44' East, 167.0 feet; thence run North 53° 17' East, 156.0 feet; thence run South 64° 45' East, 1294.5 feet; thence run North 26° 53' East, 485.0 feet; thence run North 87° 38' East, 228.2 feet; thence run South 09° 55' East, 825.0 feet; thence run South 29° 28' West, 217.2 feet; thence run South 54° 03' East, 60 feet; thence run North 56° 10' East, 254.4 feet; thence run North 56° 33' East, 158.1 feet; thence run North 82° 54' East, 326.0 feet; thence run South 84° 47' East, 497.5 feet; thence run North 10° 43' East, 143.9 feet; thence run South 80° 09' East, 287.0 feet; thence
