ENROLLED, An Act,

To alter, rearrange, and extend the boundary lines and corporate limits of the City of Bay Minette in Baldwin County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the City of Bay Minette in Baldwin County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

PARCEL 1

From the Northwest corner of Section 16, Township 3 South, Range 3 East, run South 00° 14' East 1407.3 feet along the section line; thence run East 113.6 feet to the Point of Beginning; thence run North 01° 44' East, 167.0 feet; thence run North 53° 17' East, 156.0 feet; thence run South 64° 45' East, 1294.5 feet; thence run North 26° 53' East, 485.0 feet; thence run North 87° 38' East, 228.2 feet; thence run South 09° 55' East, 825.0 feet; thence run South 29° 28' West, 217.2 feet; thence run South 54° 03' East, 60 feet; thence run North 56° 10' East, 254.4 feet; thence run North 56° 33' East, 158.1 feet; thence run North 82° 54' East, 326.0 feet; thence run South 84° 47' East, 497.5 feet; thence run North 10° 43' East, 143.9 feet; thence run South 80° 09' East, 287.0 feet; thence

1 run South 79° 07' East, 257.9 feet to the West right-of-way of
2 U.S. Highway 31; thence run along the West right-of-way of
3 U.S. Highway 31 as follows: thence run South 35° 10' West,
4 263.8 feet; thence run South 41° 49' West, 289.8 feet; thence
5 run South 45° 15' West, 300.5 feet; thence run South 38° 23'
6 West, 300.5 feet; thence run South 41° 49' West, 425.0 feet;
7 thence run North 14° 38' West, 146.0 feet; thence run North
8 06° 02' East, 304.0 feet; thence run North 24° 15' West, 239.0
9 feet; thence run South 56° 00' West, 463.0 feet; thence run
10 South 44° 39' West, 643.0 feet; thence run North 67° 17' West,
11 72.0 feet; thence run North 25° 52' East, 55.4 feet; thence
12 run North 63° 14' West, 170.9 feet to a point to be known as
13 point "A"; thence run North 22° 53' West, 84.4 feet; thence
14 run West, 152.1 feet; thence run North 00° 15' West, 443.4
15 feet; thence run North 34° 53' West, 592.6 feet; thence run
16 North 50° 30' West, 1,128.3 feet to the Point of Beginning,
17 containing in all 67 acres, more or less, EXCEPTING THEREFROM,
18 THE FOLLOWING:

19 (A) 1.84 acres in a plot known as Stapleton Cemetery
20 and described as follows: From point "A" previously described,
21 run North 06° 20' East, 39.0 feet to the Point of Beginning;
22 thence run North 25° 31' East along the East right-of-way of
23 the Old Daphne Road for 400 feet; thence run South 64° 29'
24 East, 200 feet; thence run South 25° 31' West, 400 feet;

1 thence run North 64° 29' West, 200 feet to the Point of
 2 Beginning.

3 (B) An easement strip 10 feet wide to the South of,
 4 parallel to, and equally as long as the South boundary of
 5 Stapleton Cemetery, described as follows: from Point ''A''
 6 previously described, run North 06° 20' East, 26.6 feet to the
 7 Point of Beginning; thence run South 64° 29' East, 198.9 feet;
 8 thence run North 25° 31' East, 10.0 feet; thence run North 64°
 9 29' West, 200.0 feet; thence run South 06° 20' West, 10.1 feet
 10 to the Point of Beginning, containing 0.05 acres

11 PARCEL 2

12 Also the following described property in Baldwin
 13 County, Alabama; from the Northwest corner of Section 16,
 14 Township 3 South, Range 3 East, run South 2054.2 feet; thence
 15 run East 2936 feet to the Point of Beginning; thence run South
 16 84° 47' East, 150 feet; thence run North 10° 43' East, 143.9
 17 feet; thence run North 77° 08' West, 149.9 feet; thence run
 18 South 10° 43' West, 163.9 feet to the Point of Beginning, in
 19 all containing 0.53 acres, more or less.

20 Section 2. In accordance with Section 11-42-6(b) of
 21 the Code of Alabama 1975, a map showing what territory is
 22 proposed to be annexed to the City of Bay Minette is on file
 23 in the office of the Judge of Probate in Baldwin County,
 24 Alabama, and the map is open to the inspection of the public.

1 Section 3. This act shall become effective on the
2 first day of the third month following its passage and
3 approval by the Governor, or its otherwise becoming law.
