AN ACT

To make a supplemental appropriation from Local EMA 25 Assistance Fund to the Alabama Emergency Management Agency in 26 27 the amount of \$32,945 for the fiscal year ending September 30, 2 2015; to make a supplemental appropriation from the Children's 2 Policy Council Fund to the Department of Children's Affairs in 3 the amount of \$200,000 for the fiscal year ending September 4 30, 2015; and to make a supplemental appropriation from the 5 Mail and Supply Room Revolving Fund to the Department of 6 Finance in the amount of \$1,600,000 for the fiscal year ending 7 September 30, 2015.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. In addition to all other appropriations 10 heretofore or hereafter made, there is hereby appropriated 11 \$32,945 from the Local EMA Assistance Fund to the Alabama 12 Emergency Management Agency for the fiscal year ending 13 September 30, 2015.

Section 2. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$200,000 from the Children's Policy Council Fund to the Department of Children's Affairs for the fiscal year ending September 30, 2015.

Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$1,600,000 from the Mail and Supply Room Revolving Fund to the Department of Finance for the fiscal year ending September 30, 2015.

24 Section 4. This act shall become effective 25 immediately upon its passage and approval by the Governor, or 26 upon its otherwise becoming law.
