- "(a) There is created a Board of Trustees for
  Jacksonville State University, the state educational
  institution formerly known as Jacksonville State College at
  Jacksonville, Alabama.
  - "(b) The board of trustees shall consist of two members from the congressional district in which the institution is located, one from each of the other congressional districts in the state, one at-large member, the State Superintendent of Education from the state, one at-large member from outside of the state, and the Governor, who shall be ex officio president of the board.
  - "(c) The trustees shall be appointed by the Governor, by and with the advice and consent of the Senate and, except for the first trustees appointed commencing on the effective date of the act amending this section, shall be appointed to hold office for a term of 12 six years and until their successors shall be appointed and qualified. Of the first members appointed to the board, one third shall be appointed for terms of four years, one third for terms of eight years and one third for terms of 12 years. The at-large member shall be appointed for both initial and succeeding
