Section 3. An additional tag issuance fee of four dollars (\$4) shall be charged and collected by the judge of probate for each motor vehicle license tag issued or renewed by the office of the judge of probate. No motor vehicle license tag shall be issued or renewed in the office of the judge of probate unless the tag issuance fee is paid. The additional tag issuance fee shall be collected by the judge of probate or his or her agents and deposited in the county general fund.

Section 4. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
