16	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
17	Section 1. The boundary lines and corporate limits
18	of the municipality of the City of Homewood in Jefferson
19	County are altered, rearranged, and extended to include within
20	the corporate limits of the municipality, in addition to the
21	lands now included, all of the following territory:
22	TRACT 1
23	That part of the NE $1/4$ of the SW $1/4$ of Section 14 ,
24	Township 18 South, Range 3 West of the Huntsville Principal
25	Meridian, Jefferson County, Alabama, described as follows:
26	Begin at the Southeast corner of said 1/4 - 1/4 section
27	thence North along the East boundary thereof 252.02 feet,

more or less, to its intersection with the Northeast boundary of the right of way of the New Green Springs Highway, the point of beginning; thence continuing North along the East boundary of said 1/4 - 1/4 section 186.95 feet, more or less, to its intersection with the Southwest boundary of the right of way of Columbiana Road; thence turning an angle of 60° and 06' left in a Northwesterly direction along said last mentioned right of way boundary 200.4 feet, more or less, to its intersection with the Northeast boundary of the right of way of the New Green Springs Highway thence turning an angle of 151° and 05' left in a Southeasterly direction along said last mentioned Highway right of way boundary 335.25 feet, more or less, to the point of beginning.
