8 SYNOPSIS: This bill makes an appropriation of \$100,000  
9 from the State General Fund to the Scottsboro Boys  
10 Museum and Cultural Center for the fiscal year  
11 ending September 30, 2015, requires an operations  
12 plan and an audited financial statement prior to  
13 the release of any funds, and requires quarterly  
14 and end of year performance reports.

17 TO BE ENTITLED

20 to make an appropriation of \$100,000 from the State  
21 General Fund to the Scottsboro Boys Museum and Cultural Center  
22 for the fiscal year ending September 30, 2015, to require an  
23 operations plan and an audited financial statement prior to  
24 the release of any funds, and to require quarterly and end of  
25 year performance reports.

26 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1           Section 1. For the fiscal year ending September 30,  
2           2015, there is hereby appropriated to the Scottsboro Boys  
3           Museum and Cultural Center from the State General Fund the sum  
4           of \$100,000. In addition, the appropriation made herein shall  
5           be budgeted and allotted pursuant to the Budget Management Act  
6           and Article 4 of Title 41 of the Code of Alabama, 1975, and  
7           specifically Section 41-4-93, Section 41-4-95 and Section  
8           41-4-96.

9           Section 2. Prior to the release of any funds  
10          appropriated under this bill for fiscal year 2014-2015, an  
11          operations plan for fiscal year 2014-2015 and an audited  
12          financial statement for all operations during fiscal year  
13          2012-2013 must be forwarded to the Director of Finance. It is  
14          the intent to release fiscal year 2014-2015 funds following  
15          receipts of these reports.

16          Section 3. In addition, quarterly reports for fiscal  
17          year 2014-2015 shall be made to the Director of Finance  
18          relating actual expenditures and accomplishments. An end of  
19          year performance report for the fiscal year 2014-2015 shall be  
20          made to the Director of Finance stating the work accomplished  
21          and services provided and the costs of accomplishing the work  
22          and providing the services, citing meaningful measures of  
23          program effectiveness and costs, as is required for state  
24          agencies in Code of Alabama 1975, Section 41-19-11. The  
25          Director of Finance shall forward a copy of all required  
26          reports to the Joint Fiscal Committee in a timely manner.

1                                   Section 4. This act shall become effective October  
2           1, 2014.
