- 3 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

- Section 1. (a) This section shall be known and may
 be cited as the "Registered Nurse First Assistant Consumer
 Act."
- 7 (b) The Legislature declares that the intent of this 8 act is to:
 - (1) Encourage the continued use of registered nurse first assistants who meet the qualifications of this section to provide quality, cost-effective surgical first assistant at surgery services to health care recipients in the state.
 - (2) Establish policies within managed health care agencies, workers' compensation carriers, and all private insurance companies to provide for equitable reimbursement for the first assistant at surgery services rendered by registered nurse first assistants.
 - (c) As used in this section, the following terms shall have the following meanings:
 - (1) HEALTH BENEFIT POLICY. An individual or group plan, policy, or contract for health care services issued, delivered, issued for delivery, or renewed in this state, including, but not limited to, those policies, plans, or contracts executed by the State of Alabama on behalf of state employees by a health care corporation, health maintenance organization, preferred provider organization, accident and sickness insurer, fraternal benefit society, hospital service

1 corporation, medical service corporation, workers'
2 compensation insurance carrier, or other insurer or similar
3 entity.

- (2) INSURER. An accident and sickness insurer, managed care company that provides health care coverage to its subscribers, non-profit health services corporation, fraternal benefit society, hospital service corporation, workers' compensation insurance carrier, medical service corporation, health care corporation, health maintenance organization, managed care plan other than a dental plan, or any similar entity authorized to issue contracts under this title, but shall exclude any state program funded under Title XIX of the federal Social Security Act, 42 U.S.C.A. Section 1396, et seq., and any other publicly funded state health care program.
 - (3) OPERATING ROOM NURSING. A practice of registered professional nursing in which the registered nurse provides preoperative, intraoperative, and postoperative nursing care to surgical patients.
 - (4) RECOGNIZED EDUCATIONAL CURRICULUM PROGRAM. A program that:
 - a. Addresses all content of the Association of Perioperative Registered Nurses Standards for RN First Assistant Education Programs.
 - b. Includes indicated didactic and clinical internship as required by the curriculum.
 - (5) REGISTERED NURSE FIRST ASSISTANT. A person who:

- a. Is licensed as a registered professional nurse in the State of Alabama.
 - b. Is certified in operating room nursing.

- c. Has successfully completed a registered nurse
 first assistant education program that meets the criteria of
 the Association of Perioperative Registered Nurses Standards
 for the RN First Assistant Education Programs.
 - d. Was functioning as a registered nurse first assistant as of January 1, 1993.
 - (d) Notwithstanding any provisions in policies or contracts which might be construed to the contrary, whenever any health benefit policy which is issued, executed, or renewed in this state on or after July 1, 2014, provides that any of its benefits are payable to a surgical first assistant for services rendered, the insurer shall be required to provide reimbursement for first assistant at surgery services rendered by a registered nurse first assistant, provided such services are within the scope of the registered nurse first assistant's professional license.

Section 2. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
