20 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

21 Section 1. Section 4 of Act 2013-264 is hereby
22 amended to read as follows:

23 In addition to all other appropriations, there is
24 hereby appropriated from the Education Trust Fund the follow-
25 ing amounts to be conditioned upon the availability of funds,
26 the recommendation of the Director of Finance, and the ap-
27 proval of the Governor:
