20	Relating to public K-12 education; to establish the
21	Virtual Public Schools Act; to provide for the establishment
22	of a virtual public schools by the State Board of Education;
23	to provide for the responsibilities and duties of virtual
24	public schools; to provide for the annual evaluation of each
25	virtual public school; and to require the State Department of
26	Education to promulgate rules to implement the act.
27	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. This act shall be known and may be cited as the Virtual Public Schools Act.

Section 2. The purpose of this act is to provide parents, guardians, and the State Board of Education with an alternative choice for offering additional educational resources in an effort to improve academic achievement.

Section 3. For the purposes of this act, a virtual school is a public school in which the school uses technology in order to deliver a significant portion of instruction to its students via the Internet in a virtual or remote setting.

Section 4. A virtual school may be established by the State Board of Education according to rules promulgated by the State Department of Education. A virtual school shall be a public school and shall be provided resources as any other public school in the state. Nothing in this act shall require the appropriation of locally assessed and collected revenue earmarked for local education purposes to be appropriated to virtual schools unless specifically authorized by the local board of education.

Section 5. A virtual school shall provide each student enrolled in the school with all of the following:

- (1) Access to a sequential curriculum that meets or exceeds the curriculum standards adopted by the State Board of Education. The sequential curriculum shall have an interactive program with significant online components.
- (2) The same number of instructional days, or the hourly equivalent thereof, for learning opportunities per

- academic year that is required under Section 16-13-231, Code
 of Alabama 1975, for public school students. A student, at his
 or her own pace, may demonstrate mastery or completion of a
 course or subject area and be given credit for the course or
 subject area.
 - (3) Regular assessment in language arts, math, science, and social studies.

- Section 6. For each family with a student enrolled,
 the virtual school shall do all of the following:
 - (1) Provide instructional materials.
 - (2) Ensure materials and access to necessary technology such as computer, printer, and Internet connection used for school work or, at minimum, through a physical computer lab that is available to the student through regularly scheduled times.

Section 7. A virtual school may not provide assistance to students or families to purchase instructional programs or materials. Nothing in this section shall prohibit a virtual school from reimbursing families for costs associated with their Internet connection for use in the virtual school program.

Section 8. Each teacher employed at a virtual school shall be qualified to teach in this state under existing law.

Section 9. Nothing in this act shall preclude the use of computer-based and Internet-based instruction for students in a virtual or remote setting.

Section 10. A virtual school shall maintain an

administrative office within the state. This office shall be

considered the principal place of business for the virtual

school.

Section 11. Any student who is eligible for enrollment in a public school in this state may enroll in a virtual school as either a full-time virtual school student or as a part-time virtual school student taking some of his or her courses through the virtual school. A local board of education may charge tuition to any person not enrolled in a public school within the local board of education district for attendance in a local board of education established virtual school.

Section 12. A virtual school shall be evaluated annually by State Board of Education based on all of the following criteria:

- (1) The extent to which the school demonstrates increases in student achievement according to the goals of its authorizing contract and state academic standards.
- (2) The accountability and viability of the virtual school, as demonstrated by its academic, fiscal, and operational performance.

Section 13. The State Board of Education may contract for services with nonprofit and for-profit entities in the operation and management of the virtual school.

Section 14. The State Department of Education shall promulgate rules to effectuate the purposes of this act. All

such rules shall be promulgated in accordance with the Alabama
Administrative Procedure Act, Chapter 22, Title 41, Code of
Alabama 1975.

Section 15. This act shall become effective on the
first day of the third month following its passage and
approval by the Governor, or its otherwise becoming law.
