functions, equipment, funds, and employees of the office of the license commissioner to the office of the revenue commissioner; to provide that any special fees assessed and collected by the license commissioner shall continue to be assessed and collected by the revenue commissioner; to provide for the employees of the office; to provide for the salary of the office; to provide that the county commission shall provide adequate space for the expanded office; and to provide an effective date.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 1901, is proposed and shall become valid as a part of the Constitution when all requirements of this act are fulfilled:

PROPOSED AMENDMENT

- (a) Effective October 1, 2015, the office of the License Commissioner of Mobile County is abolished and all the duties, functions, equipment, and funds of the license commissioner are transferred to the revenue commissioner.
- (b) All special fees paid to the license commissioner pursuant to any local act of the Legislature in effect before October 1, 2015, shall continue to be assessed and shall be paid to the revenue commissioner beginning on October 1, 2015.
- (c) The position of secretary to the license commissioner, authorized to be employed pursuant to Act 2010-266, 2010 Regular Session (Acts 2010, p. 487), to serve

as the secretary to the license commissioner, shall become an appointed position of the office of the revenue commissioner. The secretary shall be appointed by the revenue commissioner and serve at his or her pleasure. The salary of the secretary shall continue to be an amount that shall not exceed the salary of the secretaries of the Mobile County Commission. The secretary shall continue to be paid in the same manner as other employees of the office. Including the position specified above, the revenue commissioner may appoint up to six additional persons to serve as employees of the office in any capacity set forth by the revenue commissioner.

- (d) The salary of the revenue commissioner shall be 75 percent of the combined salaries of the license commissioner and revenue commissioner as paid immediately preceding October 1, 2015, as calculated pursuant to Act 91-368, 1991 Regular Session (Acts 1991, p. 701), Act 91-370, 1991 Regular Session (Acts 1991, p. 703), Act 97-606, 1997 Regular Session (Acts 1997, p. 1070), Act 97-617, 1997 Regular Session (Acts 1997, p. 1084), and Chapter 2A of Title 11, Code of Alabama 1975.
- (e) The county commissioner shall provide sufficient office space to accommodate the expanded functions of the office of revenue commissioner.

Section 2. An election upon the proposed amendment shall be held in accordance with Amendment 555 to the Constitution of Alabama of 1901, now appearing as Section 284.01 of the Official Recompilation of the Constitution of

Alabama of 1901, as amended, and the election laws of this 1 2 state. Section 3. The appropriate election official shall 3 assign a ballot number for the proposed constitutional amendment on the election ballot and shall set forth the 5 6 following description of the substance or subject matter of 7 the proposed constitutional amendment: "Relating to Mobile County, proposing an amendment 8 to the Constitution of Alabama of 1901, to abolish the office 9 10 of the license commissioner in Mobile County and transfer the 11 duties, functions, equipment, funds, and employees of that 12 office to the office of the revenue commissioner and to 13 provide for the salary of the revenue commissioner and the employees of the newly combined office. 14 "Proposed by Act ." 15 This description shall be followed by the following 16 17 language:
