3 To require the Legislature to repay all amounts transferred from the Alabama Trust Fund to the State General 4 5 Fund pursuant to Amendment 856 to the Constitution of Alabama of 1901 by not later than September 30, 2026; and to provide 6 7 for the minimum cumulative amounts that must be repaid at the 8 end of each fiscal year between the fiscal year ending September 30, 2014, and the fiscal year ending September 30, 9 2026. 10

11 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. This act shall be known and may be citedas The People's Trust Act.

14 Section 2. (a) Notwithstanding any other provision 15 of law to the contrary, the Legislature shall provide for the 16 repayment of all funds transferred from the Alabama Trust Fund 17 to the State General Fund pursuant to Amendment 856 to the 18 Constitution of Alabama of 1901. All funds borrowed pursuant 19 to this amendment shall be repaid to the Alabama Trust Fund by 20 not later than September 30, 2026.

(b) The total cumulative amount repaid pursuant to this section shall not be less than the following amounts on the following dates:
