Relating to Morgan County; to provide further for the distribution and expenditure of in-lieu-of-taxes payments received from the Tennessee Valley Authority distributed to Morgan County; and to repeal Act 2011-267 of the 2011 Regular Session (Acts 2011, p. 490).

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. (a) Any provision of law to the contrary notwithstanding, a portion of the proceeds allocated to Morgan County, pursuant to Act 2010-135, from the in-lieu-of-taxes payments made by the Tennessee Valley Authority shall be distributed as follows for the fiscal years specified below:

- (1) For the fiscal years beginning October 1, 2013, and October 1, 2014, the first one hundred seventy-five thousand dollars (\$175,000) shall be distributed among the Hartselle, Decatur, and Morgan County school systems to be used expressly for the support and benefit of each system's robotics programs as follows:
 - a. Decatur -- \$77,000
 - b. Morgan County -- \$70,000
- 22 c. Hartselle -- \$28,000
- 23 (2) For the fiscal year beginning October 1, 2013, until the fiscal year beginning October 1, 2022, four hundred 25 thousand dollars (\$400,000) shall be divided equally between

Τ	Athens State University and Calhoun Community College for the
2	purpose of securing funding to build a Phase II for the
3	Alabama Center for the Arts in downtown Decatur. The
