Relating to Russell County; providing for an additional expense allowance and salary for the judge of probate.

## BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Commencing on the first day of the month immediately following the effective date of this act, the Judge of Probate of Russell County shall receive an additional expense allowance in the amount of ten thousand dollars (\$10,000) per annum, which shall be in addition to all other expense allowances, compensation, or salary provided by law. This expense allowance shall be payable in equal monthly installments from the general fund of the county.

Section 2. Beginning with the expiration of the term of the incumbent judge of probate, the annual salary for the Judge of Probate of Russell County shall be increased by ten thousand dollars (\$10,000) per annum, payable in equal monthly installments from the general fund of the county and at that time, Section 1 shall become null and void. The salary provided by this act shall be the total compensation of the judge of probate and shall be in lieu of any other compensation, salary, or expense allowance currently provided by law.
