ENROLLED, An Act,

Relating to Morgan County; to provide for the allocation and expenditure of money received from the Tennessee Valley Authority and distributed to Morgan County pursuant to Act 2010-135, 2010 Regular Session (Acts 2010, p. 190), for the fiscal years 2014, 2015, and 2016.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Notwithstanding any other provision of law, after the allocation of the proceeds pursuant to Act 2013-199 of the 2013 Regular Session, any remaining proceeds allocated to Morgan County pursuant to Act 2010-135, 2010 Regular Session (Acts 2010, p. 190), from the in-lieu-of-taxes payments made by the Tennessee Valley Authority for fiscal years 2014, 2015, and 2016 shall be distributed as follows:

(1) One hundred seventy-five thousand dollars (\$175,000) each year to the City of Hartselle for lighting at the municipal soccer fields in the City of Hartselle.

(2) One hundred thousand dollars (\$100,000) each year to the United Way of Morgan County for the sole purpose of funding the Starting Strong Pre-K Initiative for a countywide Pre-K program.

(3) Two hundred seventy-five thousand dollars (\$275,000) each year to the City of Decatur for capital improvements to Jack Allen Park.

1 (4) Forty thousand dollars (\$40,000) each year to
2 the Town of Priceville for the funding of Veteran's Park.

3 (5) Seven thousand dollars (\$7,000) each year to the
4 Town of Eva for improvements to Eva Park.

5 (6) Seventeen thousand dollars (\$17,000) each year
6 to the Town of Falkville for improvements to McCaig Park.

7 (7) Ten thousand dollars (\$10,000) each year to the
8 Town of Somerville for improvements to the Old Somerville
9 Courthouse.

10 (8) Twenty-eight thousand (\$28,000) each year to the
11 Town of Trinity for improvements to Trinity Municipal Park.

12 (9) One hundred forty-eight thousand dollars
13 (\$148,000) each year to the Morgan County Commission for
14 capital improvements in the four primary county recreational
15 parks, to be administered and disbursed by the county
16 commission after consultation with the county legislative
17 delegation.

18 (10) In the event that there are not sufficient
19 funds to make the full amount of distributions above, those
20 distribution amounts shall be distributed proportionately.

21 (11) Upon the payment of the above distributions,
22 any remainder shall be distributed each year to the City of
23 Decatur for capital improvements in Jack Allen Park.

1 Section 2. This act shall become effective
2 immediately following its passage and approval by the
3 Governor, or its otherwise becoming law.
