Section 1. Section 13A-5-13, Code of Alabama 1975, is amended to read as follows:

"§13A-5-13.

4 "(a) The Legislature finds and declares the 5 following:

6 "(1) It is the right of every person, regardless of 7 race, color, religion, national origin, ethnicity, or physical 8 or mental disability, to be secure and protected from threats 9 of reasonable fear, intimidation, harassment, and physical 10 harm caused by activities of groups and individuals.

"(2) It is not the intent, by enactment of this section, to interfere with the exercise of rights protected by the Constitution of the State of Alabama or the United States.

14 "(3) The intentional advocacy of unlawful acts by 15 groups or individuals against other persons or groups and 16 bodily injury or death to persons is not constitutionally 17 protected when violence or civil disorder is imminent, and 18 poses a threat to public order and safety, and such conduct 19 should be subjected to criminal sanctions.

"(b) The purpose of this section is to impose additional penalties where it is shown that a perpetrator committing the underlying offense was motivated by the victim's actual or perceived race, color, religion, national origin, ethnicity, or physical or mental disability.

"(c) A person who has been found guilty of a crime,
the commission of which was shown beyond a reasonable doubt to
have been motivated by the victim's actual or perceived race,

color, religion, national origin, ethnicity, or physical or
 mental disability, shall be punished as follows:

"(1) Felonies:

4 "a. On conviction of a Class A felony that was found
5 to have been motivated by the victim's actual or perceived
6 race, color, religion, national origin, ethnicity, or physical
7 or mental disability, the sentence shall not be less than 15
8 years.

9 "b. On conviction of a Class B felony that was found 10 to have been motivated by the victim's actual or perceived 11 race, color, religion, national origin, ethnicity, or physical 12 or mental disability, the sentence shall not be less than 10 13 years.

14 "c. On conviction of a Class C felony that was found 15 to have been motivated by the victim's actual or perceived 16 race, color, religion, national origin, ethnicity, or physical 17 or mental disability, the sentence shall not be less than two 18 years.

19 "d. For purposes of this subdivision, a criminal 20 defendant who has been previously convicted of any felony and 21 receives an enhanced sentence pursuant to this section is also 22 subject to enhanced punishment under the Alabama Habitual 23 Felony Offender Act, Section 13A-5-9.

"(2) Misdemeanors:

25 "On conviction of a misdemeanor which was found
26 beyond a reasonable doubt to have been motivated by the
27 victim's actual or perceived race, color, religion, national

origin, ethnicity, or physical or mental disability, the defendant shall be sentenced for a Class A misdemeanor, except that the defendant shall be sentenced to a minimum of three months.

"(d) Any person who commits any of the following 5 offenses against religious property, and because of the 6 7 religious character of that property, shall be subject to the additional penalties under subsection (c): 8 "(1) Arson in the first degree pursuant to Section 9 10 13A-7-41, arson in the second degree pursuant to Section 13A-7-42, and arson in the third degree pursuant to Section 11 12 13A-7-43. "(2) Burglary in the first degree pursuant to 13 14 Section 13A-7-5, burglary in the second degree pursuant to 15 Section 13A-7-6, and burglary in the third degree pursuant to Section 13A-7-7. 16 "(3) Criminal mischief in the first degree pursuant 17 to Section 13A-7-21, criminal mischief in the second degree 18 pursuant to Section 13A-7-22, and criminal mischief in the 19 third degree pursuant to Section 13A-7-23. 20 21 "(e) For the purposes of this section, religious 22 property means any church, religious cemetery, or other place of religious worship, including fixtures or religious objects 23 contained within a place of religious worship." 24 Section 2. This act shall become effective on the 25 26 first day of the third month following its passage and 27 approval by the Governor, or its otherwise becoming law.
