10	"(a) For purposes of admission and tuition, a public
11	institution of higher education may consider that the term
12	resident student includes any of the following:

17	spouse of such an employee.
18	"b. Can verify full-time permanent employment within

22	"c. Is a member or the spouse of a member of the
23	United States military on full-time active duty stationed in

4	"(2) One who, at the time of registration, is a
5	minor and whose supporting person is a member of the United
6	States military on full-time active duty stationed in Alabama
7	under orders for duties other than attending school."
8	Section 2. The boards of trustees of each public
9	institution of higher education in the state shall adopt rules
10	and guidelines necessary to implement this section, as
11	amended. It is the intent of the Legislature that
12	constitutionally created boards of trustees comply with the
13	requirements of this section, as amended.
14	Section 3. This act shall become effective
15	immediately following its passage and approval by the
16	Governor, or its otherwise becoming law.
