8 SYNOPSIS: Currently, the Constitution of Alabama of  
9 1901, provides that no person may be elected or  
10 appointed to a judicial office after reaching the  
11 age of 70 years.

12 This bill would remove the age restriction  
13 for circuit court and district court judges.

16 TO BE ENTITLED

19 To amend Section 6.16, as added by Amendment 328 to  
20 the Constitution of Alabama of 1901, now appearing as Section  
21 155 of the Official Recompilation of the Constitution of  
22 Alabama of 1901, as amended, to remove the age restriction for  
23 circuit court and district court judges.

24 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

25 Section 1. The following amendment to the  
26 Constitution of Alabama of 1901, as amended, is proposed and  
27 shall become valid as a part thereof when approved by a

1 majority of the qualified electors voting thereon and in  
2 accordance with Sections 284, 285, and 287 of the Constitution  
3 of Alabama of 1901, as amended:

4 PROPOSED AMENDMENT

5 Section 6.16, as added by Amendment 328 to the  
6 Constitution of Alabama of 1901, now appearing as Section 155  
7 of the Official Recompilation of the Constitution of Alabama  
8 of 1901, as amended, is amended to read as follows:

9 "6.16. Retirement.

10 "The legislature shall provide by law for he  
11 retirement of judges, including supernumerary judges, with  
12 such conditions, retirement benefits, and pensions for them  
13 and their dependents as it may prescribe. No person shall be  
14 elected or appointed to a judicial office in any court except  
15 the circuit and district courts of the state after reaching  
16 the age of seventy years, provided that a judge over the age  
17 of seventy may be appointed to the office of supernumerary  
18 judge if he is not eligible to receive state judicial  
19 retirement benefits."

20 Section 2. An election upon the proposed amendment  
21 shall be held in accordance with Sections 284 and 285 of the  
22 Constitution of Alabama of 1901, now appearing as Sections 284  
23 and 285 of the Official Recompilation of the Constitution of  
24 Alabama of 1901, as amended, and the election laws of this  
25 state.

26 Section 3. The appropriate election official shall  
27 assign a ballot number for the proposed constitutional

1 amendment on the election ballot and shall set forth the  
2 following description of the substance or subject matter of  
3 the proposed constitutional amendment:

4 "Proposing an amendment to the Constitution of  
5 Alabama of 1901, to remove the age restriction of 70 years for  
6 circuit court and district court judges.

7 "Proposed by Act \_\_\_\_\_."

8 This description shall be followed by the following  
9 language:

10 "Yes ( ) No ( )."
