Section 1. Section 31-5-14 of the Code of Alabama
1975, is amended to read as follows:

4 "All For the fiscal year beginning October 1, 2012, and for fiscal years thereafter, salaries of officials and 5 6 employees of the department as provided for under this 7 chapter, and office, travel₁ and other expenses incidental to the proper establishment, operation, and maintenance of the 8 department, or offices of district or county service 9 10 commissioners, or other offices established by the State 11 Service Commissioner as provided for under this chapter, shall 12 may be paid by the State of Alabama, from the State General 13 Fund; provided, however, that each county in the state in 14 which a district service commissioner's office or a county 15 service commissioner's office is established shall furnish suitable office space in the county courthouse, or another 16 17 suitable location in the county for the use of the district service commissioner or county service commissioner, and any 18 rental, telephone, janitor, light, power, heat, or other 19 20 maintenance expense for such the office shall be paid by the 21 county. Each fiscal year, after the fiscal year ending September 30, 2013, salaries of officials and employees of the 22 23 department, as provided for under this chapter, and office, 24 travel, and other expenses incidental to the proper 25 establishment, operation, and maintenance of the department, 26 offices of district or county service commissioners, and other 27 offices established by the State Service Commissioner, as

1	provided for under this chapter, shall be paid by the State of
2	Alabama from the State General Fund; provided, however, that
