2 ENROLLED, An Act,

3 Relating to Dale County; to provide a fee for the
4 issuance of pistol permits in Dale County; to provide for the
5 deposit of the fees into the Sheriff's Law Enforcement Fund;
6 to provide for the use of the fund; and to repeal Act 85-608,
7 1985 Regular Session (Acts 1985, p. 943), relating to the
8 pistol permit fee.

9 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

10 Section 1. (a) In Dale County, the fee for the
11 issuance of a permit to carry a pistol in a vehicle or
12 concealed on or about the person as provided in Title
13 13A-11-75, Code of Alabama 1975, shall be twenty dollars
14 (\$20), which shall be collected by the sheriff or his or her
15 designated agent.

16 (b) Notwithstanding subsection (a), the fee for
17 issuing a pistol permit to a person aged 65 or older shall be
18 ten dollars (\$10).

19 Section 2. (a) All funds collected under Section 1
20 shall be deposited by the Sheriff of Dale County, or his or
21 her designated agent, in any bank located in Dale County and
22 selected by the sheriff, into a fund known as the Sheriff's
23 Law Enforcement Fund.

24 (b) The Sheriff's Law Enforcement Fund provided in
25 subsection (a) shall be drawn upon by the Sheriff of Dale

1 County, or his or her designated agent, and shall be
2 exclusively for law enforcement purposes in the interest of
3 the public and in the discharge of the duties of the office of
4 the sheriff as the sheriff sees fit.

5 (c) The establishment of the Sheriff's Law
6 Enforcement Fund as provided in this section and the use of
7 such funds shall in no way diminish or take the place of any
8 other imbursement or other source of income established for
9 the sheriff or the operation of the office.

10 Section 3. Act 85-608, 1985 Regular Session (Acts
11 1985, p. 943), is repealed and all laws or parts of law which
12 conflict with this act are repealed.

13 Section 4. This act shall become effective on the
14 first day of the third month following its passage and
15 approval by the Governor, or its otherwise becoming law.
