12 death of Mrs. Mattie Johns Howze, a lifelong resident of Lower
13 Peach Tree, Alabama, on November 27, 2017, and we uplift her
14 inspiring life and legacy with utmost reverence and respect;

16 WHEREAS, the passing of Mrs. Mattie Johns Howze
17 leaves a void in the lives of her loving family, many friends,
18 and the entire community, where she was highly regarded; and

19 WHEREAS, Mrs. Howze was born to the union of Mannie
20 Culpepper Johns and Henry Johns on October 4, 1936; she
21 accepted the Lord at a young age in the care of St. Thomas
22 A.M.E.; she faithfully served as a Missionary Church member
23 and attended St. Matthew's for 15 years in Detroit, Michigan;
24 she was a member of the Eastern Star Member Harris Beauty
25 Chapter 526, the St. Thomas A.M.E. Stewardess Board,
26 Missionary Society, and Pastor's Aid Board; and she taught
27 primary and intermediate Sunday School; and

1 WHEREAS, Mrs. Howze attended first through sixth
2 grade at the school house in Lower Peach Tree, Alabama; she
3 went to live with her sister, Dorothy Shaw and brother-in-law,
4 Reverend Shaw, in Enterprise, Alabama; she played basketball
5 for Enterprise High School and attended and sang in the choir
6 at Johns Chapel A.M.E. Church in Enterprise, Alabama; she
7 earned a Bachelor's Degree in Childhood Elementary Education
8 from Alabama State University in Montgomery, Alabama; and

9 WHEREAS, she taught elementary school in
10 Coffeetown, Alabama, for seven years until she met the love
11 of her life, Miller Howze, Jr., whom she married; the couple
12 moved to Detroit, Michigan, where Mattie continued to teach
13 elementary education for 23 years for Detroit Board of
14 Education and received her Master's in Early Childhood
15 Education from Wayne State University in Detroit, Michigan;
16 she and her family returned to Grove Hill, Alabama, after
17 spending 28 years in Detroit; and

18 WHEREAS, survivors include Millicent Howze-Simmons
19 (Leo); Ryan Troy Howze (Carla); and grandsons, Blair Simmons
20 and Da'Ryan Howze; and a faithful sister-in-law, Viola
21 Howze-Jordan; she was preceded in death by her beloved and
22 devoted husband of 24 years, Miller Bray Howze, Jr.; sisters
23 and brothers; others including Minnie Lue Johns-Cheeseburger
24 (Andrew), Dorothy Johns-Shaw (Rev. Shaw), Henry Johns, Willie
