12	WHEREAS, it is with highest commendation that we
13	recognize Deputy Chris Rogers of the Talladega County
14	Sheriff's Office as a nominee for the 2018 Alabama Legislative
15	Medal of Honor for Law Enforcement, Alabama's highest law

18	WHEREAS, on May 12, 2017, while on duty with the
19	Talladega County Sheriff's Office, Deputy Chris Rogers was
20	dispatched to a Domestic Violence call on Airport Road in
21	Oxford; upon his arrival, he was advised by a witness that the
22	suspect and the victim were inside the residence and the
23	suspect was armed with a gun; and
24	WHEREAS, as Deputy Rogers entered the residence he
25	found that the suspect was in fact armed and was waving the
26	gun around and pointing the gun at the victim; after giving

the suspect verbal commands to drop his weapon, the suspect

1 continued to wave the gun and make threats to shoot the 2 victim; and 3 WHEREAS, the suspect then pointed the gun back at the victim forcing Deputy Rogers to fire his service weapon, 4 5 ultimately disabling the suspect; and 6 WHEREAS, due to Deputy Rogers' bravery, quick 7 action, and good Police work, there is no doubt that he saved 8 lives on that day; and 9 WHEREAS, Deputy Rogers has exceeded the expectations 10 of his duties as a deputy with the Talladega County Sheriff's Office; his split-second decision saved lives; he strives 11 12 daily to make a positive impact upon the lives of others; and 13 WHEREAS, Deputy Rogers epitomizes the qualities of 14 those who serve and protect, and he is truly deserving of this 15 distinguished nomination for the Legislative Medal of Honor 16 for Law Enforcement; now therefore, 17 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH 18 HOUSES THEREOF CONCURRING, That we do hereby recognize and honor Deputy Chris Rogers as a nominee for the 2018 19 20 Legislative Medal of Honor for Law Enforcement and direct that 21 he receive a copy of this resolution as evidence of our
