8 SYNOPSIS: This bill would create the Blue Alert  
9 system, which is a system for notifying certain  
10 participants in the system when a suspect of a  
11 crime involving the death or serious injury of a  
12 peace officer has not been apprehended and law  
13 enforcement personnel have determined that the  
14 suspect may be a serious threat to the public or  
15 when a peace officer becomes missing while in the  
16 line of duty under circumstances warranting concern  
17 for the safety of the peace officer.

18 This bill would give the Director of the  
19 Department of Public Safety the authority to  
20 oversee the alert system and adopt rules to  
21 implement the alert system.

22 This bill would allow the Department of  
23 Public Safety to recruit certain media and certain  
24 entities and persons to assist in implementing this  
25 act and to give the department the authority to  
26 enter into agreements with participants in the

1 alert system to provide necessary support for the  
2 alert system.

3 This bill would require a law enforcement  
4 agency participating in the alert system to  
5 cooperate with the department and assist in  
6 developing and implementing the alert system, would  
7 require the law enforcement agency to establish a  
8 plan for providing information to its officers,  
9 investigators, or employees once the alert system  
10 has been activated, and would require the law  
11 enforcement agency to utilize a rapid response  
12 telephone system that alerts residents in a  
13 targeted area.

14 This bill would limit the liability of an  
15 entity or individual involved in the dissemination  
16 of an alert generated through the alert system.

18 A BILL

19 TO BE ENTITLED

20 AN ACT

21  
22 To create the Blue Alert system; to give the  
23 Director of the Department of Public Safety the authority to  
24 oversee the alert system and adopt rules to implement the  
25 alert system; to give the department certain authority; to  
26 require a law enforcement agency participating in the alert  
27 system to meet certain conditions; and to limit the liability

1 of an entity or individual involved in the dissemination of an  
2 alert generated through the alert system.

3 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

4 Section 1. (a) For the purposes of this section, the  
5 following terms shall have the following meanings:

6 (1) ALERT SYSTEM. The Blue Alert system.

7 (2) DEPARTMENT. The Department of Public Safety.

8 (3) DIRECTOR. The Director of the Department of  
9 Public Safety.

10 (4) LAW ENFORCEMENT AGENCY. A law enforcement agency  
11 with jurisdiction over the search for a suspect in a case  
12 involving the death or serious injury of a peace officer or an  
13 agency employing a peace officer who is missing in the line of  
14 duty.

15 (5) PEACE OFFICER. A person who is certified to  
16 exercise the power of arrest under the laws of this state.

17 (b) There is established a statewide alert system  
18 known as "Blue Alert" which shall be developed and implemented  
19 by the director, who is the statewide coordinator of the alert  
20 system.

21 (c) The alert system may be activated under either  
22 of the following circumstances:

23 (1) When a suspect of a crime involving the death or  
24 serious injury of a peace officer has not been apprehended and  
25 law enforcement personnel have determined that the suspect may  
26 be a serious threat to the public.

1           (2) When a peace officer becomes missing while in  
2 the line of duty under circumstances warranting concern for  
3 the safety of the peace officer.

4           (d) The director shall do all of the following:

5           (1) Adopt rules necessary to ensure the proper  
6 implementation of the alert system, including instructions on  
7 the procedures for activating and deactivating the alert  
8 system.

9           (2) Prescribe forms for use by local law enforcement  
10 agencies in requesting activation of the alert system.

11          (e) The department may do any of the following:

12          (1) Recruit public and commercial television, radio,  
13 cable, print, and other media, private commercial entities,  
14 state or local governmental entities, the public, and other  
15 appropriate persons to assist in developing and implementing  
16 the alert system.

17          (2) Enter into agreements with participants in the  
18 alert system to provide necessary support for the alert  
19 system.

20          (f) A law enforcement agency participating in the  
21 alert system shall do all of the following:

22          (1) Cooperate with the department and assist in  
23 developing and implementing the alert system.

24          (2) Establish a plan for providing relevant  
25 information to its officers, investigators, or employees, as  
26 appropriate, once the alert system has been activated.

1           (3) Utilize a rapid response telephone system that  
2 alerts residents in a targeted area.

3           (g) Upon notification by a law enforcement agency  
4 that a suspect in a case involving death or serious injury of  
5 a peace officer has not been apprehended and may be a serious  
6 threat to the public, the director shall activate the alert  
7 system and notify the appropriate participants in the alert  
8 system, as established by rule, if all of the following  
9 conditions are met:

10           (1) A law enforcement agency believes that a suspect  
11 has not been apprehended.

12           (2) A law enforcement agency believes that the  
13 suspect may be a serious threat to the public.

14           (3) Sufficient information is available to  
15 disseminate to the public that could assist in locating the  
16 suspect.

17           (h) Upon notification by a law enforcement agency  
18 that a peace officer is missing while in the line of duty  
19 under circumstances warranting concern for the safety of the  
20 peace officer, the director shall activate the alert system  
21 and notify the appropriate participants in the alert system,  
22 as established by rule, if sufficient information is available  
23 to disseminate to the public that could assist in locating the  
24 missing peace officer.

25           (i) The area of the alert may be less than statewide  
26 if the director determines that the nature of the event makes

1 it probable that the suspect did not leave a certain  
2 geographic location.

3 (j) Before requesting activation of the alert  
4 system, a law enforcement agency shall verify that the  
5 criteria described under subsections (g) or (h) have been  
6 satisfied. The law enforcement agency shall assess the  
7 appropriate boundaries of the alert based on the nature of the  
8 suspect and the circumstances surrounding the crime or the  
9 last known location of the missing police officer.

10 (k) The director shall terminate any activation of  
11 the alert system with respect to a particular incident if any  
12 of the following circumstances occur:

13 (1) The suspect or peace officer is located or the  
14 incident is otherwise resolved.

15 (2) The director determines that the alert system is  
16 no longer an effective tool for locating the suspect or peace  
17 officer.

18 (l) A law enforcement agency shall notify the  
19 director immediately when the suspect is located and in  
20 custody or when the peace officer is found.

21 (m) An entity or individual involved in the  
22 dissemination of an alert generated through the alert system  
23 pursuant to this section shall not be liable for any civil  
24 damages arising from such dissemination.

25 Section 2. This act shall become effective on the  
26 first day of the third month following its passage and  
27 approval by the Governor, or its otherwise becoming law.
