Relating to Jefferson County; to provide that the
proceeds from the taxes including any interest and penalties
levied pursuant to Act 2001-546, 2001 Regular Session (Acts
2001, p. 1099); Act 95-783, 1995 Regular Session (Acts 1995,
p. 1860); Act 747 of the 1979 Regular Session (Acts 1979, p.

3 the county general fund; to provide that no county tax
4 proceeds shall be diverted that are pledged and used for the
5 payment of bonds of the Birmingham Jefferson Civic Center; and
6 to provide that that act may not be construed to relieve the
7 county of its obligation to appropriate funds for indigent
8 health care for county residents.

9 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

10 Section 1. This act shall apply only in Jefferson
11 County.

12 Section 2. (a) Except as provided in subsections (b)
13 and (c), the total proceeds including any interest and
14 penalties of the tax or fees levied pursuant to Act 2001-546,

Regular Session (Acts 1951, p. 1132); and Act 304 of the 1947 First Special Session (Acts 1947, p. 158), shall be paid into the general treasury of the county as received and collected and may be expended for county public purposes and in the manner as the governing body of the county shall determine.

(b) No county tax proceeds shall be diverted pursuant to this act that are currently pledged to or used for the payment of bonds issued for the financing of the Birmingham Jefferson Civic Center.

(c) This act may not be construed to relieve the county of its obligation to appropriate funds for indigent health care for county residents.

Section 3. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
