2 ENROLLED, An Act,

3 Relating to Shelby County in the Eighteenth Judicial
4 Circuit; to amend Section 1 of Act 2007-306, 2007 Regular
5 Session (Acts 2007, p. 554); to provide further for the
6 distribution of the solicitor's fee to the circuit or
7 municipal court clerk and to the Solicitor's Fund.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. Section 1 of Act 2007-306, 2007 Regular
10 Session (Acts 2007, p. 554), is amended to read as follows:

11 "Section 1. In all juvenile, traffic, criminal, and
12 quasi-criminal cases in the juvenile, district, circuit, and
13 municipal courts in Shelby County in the Eighteenth Judicial
14 Circuit, a docket fee, hereinafter referred to as solicitor's
15 fee, shall be assessed in each case. The fees, when collected,
16 shall be distributed monthly as follows: Three dollars (\$3)
17 from each case to the circuit clerk to be deposited into the
18 circuit clerk's fund or, if the case originates in the
19 municipal court, three dollars (\$3) to the municipal court
20 clerk to be deposited into the municipal clerk's fund or the
21 fund otherwise established for the operation of the office of
22 the municipal court, to be used as provided by law for the
23 operation of the office of the circuit court clerk or
24 municipal court clerk as the case may be and the remainder of
25 each fee to the Solicitor's Fund or District Attorney's Fund

1 in the county or to the fund that may be hereafter prescribed
2 by law for the solicitor's fee. The solicitor's fee shall be
3 in an amount not less than an amount equal to any and all
4 docket fees or court costs which are to be collected and
5 distributed to the Fair Trial Tax Fund in the cases. In no
6 event shall the solicitor's fees be less than an amount equal
7 to the Fair Trial Tax Fund docket fees which are prescribed
8 for an adjudication or finding of guilt of the criminal
9 offense charged."

10 Section 2. This act shall become effective on the
11 first day of the third month following its passage and
12 approval by the Governor, or its otherwise becoming law.
