4 ENROLLED, An Act,

5 To amend Section 2-14-4 of the Code of Alabama 1975,
6 relating to honeybees shipped or moved into this state; to
7 further provide the penalty for violations; to provide for the
8 destruction under certain conditions of hives brought into
9 this state in violation of this section after notice to the
10 owners; to specify that this section does not apply to bees
11 brought into this state pursuant to a compliance agreement
12 with the Department of Agriculture and Industries; and in
13 connection therewith would have as its purpose or effect the
14 requirement of a new or increased expenditure of local funds
15 within the meaning of Amendment 621 of the Constitution of
16 Alabama of 1901, now appearing as Section 111.05 of the
17 Official Recompilation of the Constitution of Alabama of 1901,
18 as amended.

19 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

20 Section 1. Section 2-14-4 of the Code of Alabama
21 1975, is amended to read as follows:

22 "§2-14-4.

23 "(a) All honeybees shipped or moved into the State
24 of Alabama shall be accompanied by a certificate of
25 inspection, signed by the apiary inspector or other official

1 performing similar duties of the state or country from which
2 shipment is made, certifying that the bees and the combs and
3 hives from which the bees were taken have been inspected by
4 such official and that the bees, their combs, and hives are
5 apparently free from contagious and infectious diseases. The
6 inspection provided for in this section shall be based upon an
7 actual examination of the bees and their combs, and hives,
8 such examination or inspection to be made during brood-rearing
9 and within a period of 60 days preceding the date of shipment.
10 The inspection certificate required under this section shall
11 be attached to each parcel or package of each shipment or
12 movement in a conspicuous place, plainly written. All
13 shipments or movements of honeybees into the State of Alabama
14 shall be in combless packages only, and shipments or movements
15 of honeybees into this state in violation of the requirements
16 of this section shall be unlawful.

17 "(b) It shall also be unlawful to ship or move into,
18 within or out of the state a queen bee or other bees in
19 packages or cages that contain food, any part of which is
20 honey.

21 "(c) Any person moving bees into this state on a
22 comb in violation of this section shall be fined one hundred
23 dollars (\$100) per hive. The owner or other person in
24 possession of the hives shall be given notice by the
25 Department of Agriculture and Industries to move the hives

1 within seven days of the notice. If the hives are not moved
2 pursuant to the order of the department, the hives shall be
3 destroyed. Upon conviction of a violation under this
4 subsection, the judge may award a person providing information
5 leading to the conviction a reward to be paid from the fine
6 proceeds in an amount not to exceed one-half of the fines.

7 "(d) This section shall not apply to bees moved into
8 this state pursuant to a compliance agreement with the
9 Department of Agriculture and Industries as provided by rule
10 of the department."

11 Section 2. This act shall become effective on the
12 first day of the third month following its passage and
13 approval by the Governor, or its otherwise becoming law.
