8 SYNOPSIS: This bill would propose a local amendment to
9 the Constitution of Alabama of 1901, relating to
10 Perry County, to authorize the Legislature to fix,
11 regulate, and alter the fees, commissions,
12 allowances, and salaries, including the method and
13 basis of compensation, to be charged or received by
14 the sheriff of the county.

20 Relating to Perry County; proposing an amendment to
21 the Constitution of Alabama of 1901, to authorize the
22 Legislature to fix, regulate, and alter the fees, commissions,
23 allowances, and salaries, including the method and basis of
24 compensation, to be charged or received by the sheriff of the
25 county.

26 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

1 Section 1. The following amendment to the
2 Constitution of Alabama of 1901, is proposed and shall become
3 valid as a part of the Constitution when all requirements of
4 this act are fulfilled:

5 PROPOSED AMENDMENT

6 The Legislature, from time to time, by general or
7 local laws applicable to or operative in Perry County, may
8 fix, regulate, and alter the fees, commissions, allowances,
9 and salaries, including the method and basis of compensation,
10 to be charged or received by the sheriff of the county; and
11 may place the sheriff on a salary and provide for the fees,
12 commissions, allowances, and percentages collectible by the
13 sheriff, to be paid into the county treasury.

14 Section 2. An election upon the proposed amendment
15 shall be held in accordance with Amendment 555 to the
16 Constitution of Alabama of 1901, now appearing as Section
17 284.01 of the Official Recompilation of the Constitution of
18 Alabama of 1901, as amended, and the election laws of this
19 state.

20 Section 3. The appropriate election official shall
21 assign a ballot number for the proposed constitutional
22 amendment on the election ballot and shall set forth the
23 following description of the substance or subject matter of
24 the proposed constitutional amendment:

25 "Relating to Perry County; proposing an amendment to
26 the Constitution of Alabama of 1901, to authorize the
27 Legislature to fix, regulate, and alter the fees, commissions,

1 allowances, and salaries, including the method and basis of
2 compensation, to be charged or received by the sheriff of the
3 county.

4 "Proposed by Act _____."

5 This description shall be followed by the following
6 language:
