Southwest corner of Section 8, Township 10 North, Range 3 1 2 West; thence run due South to the Southeast corner of Section 18, Township 10 North, Range 3 West; thence run due West along 3 section line to the Southwest corner Section 18, Township 10 North, Range 3 West; thence run due North, along section line 6 to the Southwest corner of Section 31, Township 11 North, 7 Range 3 West; thence run due West along section line to the Southwest corner of Section 36, Township 11 North, Range 4 9 West; thence run due North along the section line to the Northwest corner of Section 36, Township 11 North, Range 4 West; thence run due East along section line to the Northwest 11 12 corner of Section 31, Township 11 North, Range 4 West to Point 13 of Beginning.

Section 2. In accordance with Section 11-42-6(b) of the Code of Alabama 1975, a map showing what territory is proposed to be annexed to the Town of Gilbertown is on file in the office of the Judge of Probate in Choctaw County, Alabama, and the map is open to the inspection of the public.

Section 3. Section 1 of this act shall become operative only if approved by the qualified electors who reside within the territory described in Section 1 who vote in a referendum election to be held on the date of the 2012 Gilbertown municipal election. The notice of the election shall be given by the Judge of Probate of Choctaw County, and

the elections shall be held, conducted, and the results 1 2 canvassed in conjunction with the Gilbertown municipal election on August 28, 2012. The question shall be, "Do you 3 favor the adoption of Act No. of the Session of the Alabama Legislature which alters, rearranges, and extends the 5 corporate limits of the Town of Gilbertown in Choctaw County? 6 7 Yes () No ()." The Town of Gilbertown shall pay any costs and expenses incidental to the election. If a majority of the 8 votes cast in the election are "Yes," Section 1 of this act 9 10 shall become operative immediately. If the majority of the votes are "No," this act shall be repealed and shall have no 11 12 further effect.

Section 4. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
