13 Relating to trespassers; to add Section 6-5-345 to
14 the Code of Alabama 1975, to codify case law relating to the
15 duty of care that an owner of real property owes to certain
16 trespassers on his or her property.

17 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

18 Section 1. Section 6-5-345 is added to Article 18,
19 Chapter 5, of Title 40 of the Code of Alabama 1975, to read as
20 follows:

21 §6-5-345.

22 (a) For the purpose of this section, the following
23 words have the following meanings:

24 (1) POSSESSOR OF REAL PROPERTY OR POSSESSOR. The
25 owner, lessee, renter, or other lawful occupant of real
26 property.

(2) TRESPASSER. A person who goes upon the premises
of another without permission or invitation, expressed or

1 implied, or who, after rightfully entering upon the premises
2 of another, remains on the premises after consent or license
3 to enter or use the premises has been terminated.

4 (b) (1) A possessor of real property owes no duty of
5 care to a trespasser except to:

6 a. Refrain from causing wanton or intentional
7 injury, including by a trap or pitfall.
8 b. Exercise reasonable care to avoid causing injury
9 to a known trespasser in a position of peril and to use
10 reasonable care to warn a known trespasser of dangers known by
11 the possessor to exist on the property.

12 c. Exercise reasonable diligence to warn a
13 trespasser of dangers known after discovery that the
14 trespasser is in a position of peril after the possessor has
15 knowledge of the presence of the trespasser.

16 d. Exercise reasonable care to warn a known
17 trespasser of dangers known by the possessor to exist on the
18 property after the possessor becomes aware of the danger to
19 the trespasser. Nothing in this section shall diminish,
20 change, amend, or otherwise affect the open and obvious
21 doctrine.

22 (2) A possessor of real property, however, may cause
23 injury or use force to prevent or terminate a trespass as
24 permitted at common law or in Title 13A, Chapter 3, Article 2.

25 (c) Notwithstanding the provisions of subsection
26 (b), a possessor of real property may be subject to liability

1 for physical injury or death to a child trespasser caused by
2 an artificial condition upon the real property of the
3 possessor, if all of the following apply:

4 (1) The place where the condition existed is one
5 upon which the possessor knew or had reason to know that a
6 child would be likely to trespass.

7 (2) The condition is one of which the possessor knew
8 or had reason to know and which the possessor realized or
9 should have realized would involve an unreasonable risk of
10 death or serious bodily harm to a child.

11 (3) The injured child, because of his or her youth,
12 did not discover the condition or realize the risk involved in
13 intermeddling with the condition or in coming within the area
14 made dangerous by it.

15 (4) The utility to the possessor of maintaining the
16 condition and the burden of eliminating the danger was slight
17 as compared with the risk to the child.

18 (5) The possessor failed to exercise reasonable care
19 to eliminate the danger or otherwise to protect the child.

20 (d) Notwithstanding the provisions of subsection
21 (c), the duty owed by the possessor of real property to a
22 child trespasser with respect to a natural condition is the
23 same as that owed in subsection (b).

24 (e) The intent of the Legislature in enacting this
25 section is to reject the adoption of the Third Restatement of
26 Torts with respect to the duty of a possessor of real property

1 to a trespasser. Nothing in this section shall diminish,
2 change, amend, or otherwise affect the provisions of Sections
3 35-15-1 through 35-15-40, Code of Alabama 1975.

4 Section 2. This act shall become effective
5 immediately following its passage and approval by the
6 Governor, or its otherwise becoming law.
