8 SYNOPSIS: This bill makes an appropriation of \$632,997
9 from the Education Trust Fund to Talladega College
10 in Talladega, Alabama for the support and
11 maintenance of the educational program of the
12 institution, for the fiscal year ending September
13 30, 2016; provides that the appropriation is
14 subject to certain provisions of the Code of
15 Alabama 1975; requires an operations plan and an
16 audited financial statement prior to the release of
17 any funds; and requires an end of year report.

20 TO BE ENTITLED

21 AN ACT

23 To make an appropriation of \$632,997 from the
24 Education Trust Fund to Talladega College in Talladega,
25 Alabama for the support and maintenance of the educational
26 program of the institution, for the fiscal year ending
27 September 30, 2016; to provide that the appropriation is

1 subject to certain provisions of the Code of Alabama 1975; to
2 require an operations plan and an audited financial statement
3 prior to the release of any funds; and to require an end of
4 year report.

5 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

6 Section 1. There is hereby appropriated the sum of
7 \$632,997 from the Education Trust Fund to Talladega College in
8 Talladega, Alabama for the support and maintenance of the
9 educational program of the institution, for the fiscal year
10 ending September 30, 2016.

11 Section 2. The above appropriation is made for the
12 support of public education in Alabama and for the support and
13 maintenance of the above program. The appropriation shall be
14 subject to the provisions, terms, conditions, and limitations
15 of the Budget and Financial Control Act, Code of Alabama 1975,
16 Sections 41-4-80 et seq.; the provisions of The Budget
17 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
18 et seq.; and any other provisions of this act.

19 Section 3. (a) Prior to the release of any funds
20 appropriated under this act the following reports shall be
21 submitted:

22 (1) An operations plan for the fiscal year
23 2015-2016, including goals and measurable performance
24 indicators, shall be submitted to and approved by the Director
25 of Finance, as provided for state agencies in Code of Alabama
26 1975, Section 41-19-10.

(2) An audited financial statement for all operations during the fiscal year 2013-2014.

(b) It is the intent that funds appropriated for fiscal year 2015-2016 shall be released by the Director of Finance following receipt of the above reports.

(c) In addition, quarterly reports shall be made to the Director of Finance relating actual expenditures and accomplishments to planned expenditures and accomplishments.

An end of year performance report for the fiscal year 2015-2016 shall be made to the Director of Finance stating the work accomplished and the services provided and the costs of accomplishing the work and providing the services, citing meaningful measures of program effectiveness and costs, as is required for state agencies in Code of Alabama 1975, Section 41-19-11.

(d) The Director of Finance shall forward a copy of all required reports to the Joint Fiscal Committee in a timely manner.

Section 4. This act shall become effective October 1, 2015.
