8 MOURNING THE DEATH OF MR. CHARLIE OLIVER SEALY, SR.

10 WHEREAS, with homage and sorrow we record the death
11 of Mr. Charlie Oliver Sealy, Sr., on January 10, 2010, at the
12 age of 90 years; and

13 WHEREAS, born in Ralph, Alabama, he was the son of
14 Charlie Earl Sealy and Mary McKinney Sealy; he was ordained as
15 a Deacon and a active member of Forest Lake Baptist Church and
16 Calvary Baptist Church; and

17 WHEREAS, a graduate of Tuscaloosa County High
18 School, he served 5 years in WWII, and returned home and began
19 a remarkable career in real estate development that spanned
20 six decades; and

21 WHEREAS, Mr. Sealy was a dynamic leader and
22 successful businessman, he was founder of the Sealy Company
23 that built and managed over 8500 apartment homes in four
24 states; he was also involved in the insurance, banking, and
25 environmental service industries; and

26 WHEREAS, Mr. Sealy, a visionary who became
27 well-known for his contribution to the development industry,

1 served as a charter member and as a National Director of the
2 Homebuilders of Tuscaloosa; he served as President and
3 National Director of the Alabama Real Estate Association; he
4 was instrumental in the formation of the Industrial
5 Development Authority; he was named Northport Outstanding
6 Business Leader in 2004, received the Pillars of West Alabama
7 Award in 2005, and the Tuscaloosa County High School
8 Outstanding Alumnus of the Year in 1989; and

9 WHEREAS, he leaves to mourn his death his beloved
10 wife of 63 years, Virginia Ray Sealy; a son, Charlie Sealy,
11 Jr., (Debra); daughter, Gina Sealy Miers; grandchildren,
12 Charlie O. Sealy III (Sasha), Jennifer Lamon Pass (Dave),
13 Christina Sealy and Maria Sealy; and.

14 WHEREAS, Mr. Sealy was a great Alabamian who
15 excelled in many fields through the years; he earned
16 widespread respect for his ranging capabilities and for his
17 significant contributions to the state; now therefore,

19 HOUSES THEREOF CONCURRING, That it is with profound sadness
