9 honored by many friends, family members, and well-wishers at a
10 festive party in celebration of her Centennial Birthday, she
11 was featured on television on "The Today Show," where she
12 attributed her longevity to "living right with God, drinking
13 lots of water, and having a little cake and vanilla ice cream
14 every day"; and

15 WHEREAS, through the years and in all her endeavors,
16 Catherlean Cameron Lavender has earned widespread respect for
17 her exceptional abilities and tireless dedication; with her
18 keen mind, kind heart, and indomitable spirit, she remains an
19 inspiration to those who are privileged to know her; now
