8 COMMENDING COREY RILLING ON ATTAINING THE RANK OF
9 EAGLE SCOUT IN THE BOY SCOUTS OF AMERICA.

11 WHEREAS, commendations and congratulations are
12 extended to Corey Rilling of Brewton, Alabama, on attaining
13 the rank of Eagle Scout, the highest rank in the Boy Scouts of
14 America; and

15 WHEREAS, the Eagle Scout Award, earned by only a
16 small percentage of Scouts, involves the completion of an
17 Eagle Project and represents many years of diligence in
18 pursuit of a worthy goal that brings honor to the Scout, his
19 family, and his troop; work begins at age 11 and must be
20 completed by the Scout's 18th Birthday, and Corey finished at
21 age 17; and

22 WHEREAS, Corey is a member of Troop 42 of Brewton,
23 sponsored by the First United Methodist Church of Brewton; he
24 has progressed successfully through the levels of Scouting,
25 fulfilling many leadership roles while also meeting the
26 demanding requirements for achieving the Eagle Scout Award;

2 and mounted owl boxes at Burnt Corn Creek Park; and

3 WHEREAS, in addition to completing an Eagle Project,
4 an Eagle Scout must earn at least 21 Merit Badges as evidence
5 of mastery in various Scouting skills, and must strive to
6 conduct himself with honor, loyalty, courage, cheer, and
7 service, the five integral responsibilities of a Scout; and

8 WHEREAS, Corey is an outstanding student-athlete at
9 T. R. Miller High School, where he plays both varsity football
10 and varsity baseball; he also participates in extracurricular
11 activities and has contributed countless volunteer hours to
12 worthy causes, including working with Habitat for Humanity and
13 taking part in a Wheelchair Mission Trip to Costa Rica; his
14 proud parents are Randy and Anne Rilling of Brewton; and

15 WHEREAS, through the years, Corey has exhibited
16 those hard-won characteristics of trustworthiness,
17 self-discipline, and good citizenship, all components of the
18 Scouting program; with the guidance and support of his
19 Scouting leaders, he has earned the esteem of his community,
20 fellow Scouts, and all Alabamians; now therefore,
