3 RECOGNIZING CERVICAL CANCER AWARENESS MONTH.
4

5 WHEREAS, cervical cancer is a serious public health
6 problem facing women in the United States, and 1 in 145 women
7 in the United States will be diagnosed with cervical cancer
8 during their lifetime; and

9 WHEREAS, the American Cancer Society predicts 11,270
10 U.S. and 190 Alabama women will develop cervical cancer, and
11 4,070 women will die of cervical cancer during 2010; and

12 WHEREAS, cervical cancer takes a tremendous health,
13 emotional, and financial toll on the women of Alabama, and
14 according to the National Cancer Institute, an average of 211
15 Alabama women were diagnosed with cervical cancer and 78 died
16 each year between 2002 and 2006, the latest reporting years;
17 and

18 WHEREAS, an estimated \$2 billion is spent each year
19 on treatment of cervical cancer in the United States and more
20 than an estimated \$5 billion in direct and indirect costs are
21 incurred in the prevention, diagnosis, and treatment of
22 cervical cancer in the United States each year; and

23 WHEREAS, factors associated with poverty and race
24 contribute to substantial differences in cervical cancer
25 incidence and mortality; Hispanic and African-American women

1 are less likely to be screened for cervical cancer and are
2 more likely to be diagnosed with later stage cancers that are
3 less likely to respond to treatment; and

4 WHEREAS, African-American women are 30 percent more
5 likely to develop cervical cancer than white women and are
6 more than twice as likely to die of the disease, and Hispanic
7 women are about twice as likely to develop cervical cancer as
8 non-Hispanic white women and are about 50 percent more likely
9 to die of cervical cancer than white women; and

10 WHEREAS, pre-cancerous lesions and cervical cancer
11 can be prevented with vaccines, detected with screening, and
12 treated successfully with early detection; and

13 WHEREAS, cervical cancer can be eliminated in our
14 lifetime through innovative collaborations and partnerships
15 between state and local health departments, medical providers,
16 school systems, women's health advocates, and the private
17 business sector; now therefore,

18 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
19 HOUSES THEREOF CONCURRING, That, in an effort to reduce the
20 occurrence of cervical cancer in Alabama, we urge the Alabama
21 Department of Public Health to provide for free cervical
22 cancer education, screening, and vaccination of women, and
23 hereby declare January as Cervical Cancer Awareness Month.
