3 MOURNING THE DEATH OF MR. GERALD DEWITT COLVIN, SR.

5 WHEREAS, we note with deep regret the passing of Mr.
6 Gerald DeWitt Colvin, Sr., at the age of 90 years; and

7 WHEREAS, Mr. Colvin, a native of Edgewater who lived
8 most of his life in Jasper, had resided for the past three
9 years at St. Martin's in the Pines in Birmingham; and

10 WHEREAS, Mr. Colvin served with distinction in the
11 United States Army Air Corps during World War II, earning a
12 Bronze Star; after the War, he served in the Air Force Reserve
13 and the Alabama National Guard before retiring as a Lieutenant
14 Colonel; and

15 WHEREAS, Mr. Colvin and his wife, Sara Serena Boykin
16 Colvin, graduated from the University of Alabama School of Law
17 and practiced law in Jasper; he served as Walker County
18 District Judge for a number of years and later served as
19 County District Attorney; and

20 WHEREAS, Mr. Colvin was an active member of St.
21 Mary's Episcopal Church, where he served in a number of
22 positions; and

23 WHEREAS, Mr. Colvin was preceded in death by his
24 wife, Sara Serena Boykin Colvin; sisters, Evelyn Louise

1 Colvin, Helen Marie Colvin Bonner, and Vivian Eloise Colvin;
2 and brother, Lewis Weston Colvin, Jr.; and

3 WHEREAS, Mr. Colvin is survived by his sons, Gerald
4 DeWitt (Jimmie Ann) Colvin, Jr., and Edward Weston (Memily)
5 Colvin; daughters, Serena Colvin (Parkin) Hunter and Carol Ann
6 Colvin (John) Moore; grandchildren, Gerald DeWitt (Melissa)
7 Colvin, III, Jeffrey Harwell (Shelly) Colvin, Andrew Bennett
8 (Susan) Colvin, Carrie Ann Colvin (Matt) Alling, Clayton
