3 COMMENDING MRS. WANDA JACKSON ROBINSON UPON HER
4 APPOINTMENT AS DIRECTOR OF THE MAC SIM BUTLER MONTGOMERY
5 COUNTY DETENTION FACILITY.

7 WHEREAS, commendations are extended to Mrs. Wanda
8 Jackson Robinson of Montgomery, Alabama, on the occasion of
9 her appointment as Director of the Mac Sim Butler Montgomery
10 County Detention Facility; and

11 WHEREAS, Wanda Robinson was promoted to the rank of
12 colonel and appointed as the director of the detention
13 facility on November 30, 2009; she became the first Black
14 female to hold either designation in the Montgomery County
15 Sheriff's Office, and prior to this promotion, served as the
16 first Black female major and Assistant Director of Detention
17 and the first Black female captain; and

18 WHEREAS, Mrs. Robinson provides administrative
19 leadership by supervising her subordinates, investigating and
20 resolving complaints, preparing and monitoring the facility's
21 budget, and by developing facility policies and procedures
22 that ensure the safety of the inmates and officers; in
23 addition, Mrs. Robinson acts as a liaison between the facility
24 and the legal system; and

1 WHEREAS, Wanda Robinson, a native of Montgomery, is
2 a graduate of Robert E. Lee High School and Alabama State
3 University, with a Bachelor of Science Degree; she is the wife
4 of Timothy D. Robinson, Sr., mother to one son, Timothy D.
5 Robinson, Jr., and grandmother to Kalleal and Timothy Kavaris;
6 she is also a lifelong member of Weeping Willow Baptist Church
7 where she serves as a trustee; she is member of the Montgomery
8 Alumnae Chapter of Delta Sigma Theta Sorority, Inc., which she
9 currently serves as Chair of Program Outreach, and volunteers
10 extensively; she is a dedicated member of the Montgomery
11 County Sheriff's Office, where she volunteers in many of their
12 community endeavors; and

13 WHEREAS, Wanda Robinson's achievements in the
14 Montgomery County Sheriff's Office will stand as a legacy in
15 the Black community and the Montgomery community as a whole;
16 now therefore,

17 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
18 HOUSES THEREOF CONCURRING, That Mrs. Wanda Jackson Robinson is
19 highly commended upon her appointment as Director of the Mac
20 Sim Butler Montgomery County Detention Facility, and by copy
21 of this resolution, we honor her accomplishments.
