3 MOURNING THE DEATH OF MR. CHARLIE OLIVER SEALY, SR.

5 WHEREAS, with homage and sorrow we record the death
6 of Mr. Charlie Oliver Sealy, Sr., on January 10, 2010, at the
7 age of 90 years; and

8 WHEREAS, born in Ralph, Alabama, he was the son of
9 Charlie Earl Sealy and Mary McKinney Sealy; he was ordained as
10 a Deacon and a active member of Forest Lake Baptist Church and
11 Calvary Baptist Church; and

12 WHEREAS, a graduate of Tuscaloosa County High
13 School, he served 5 years in WWII, and returned home and began
14 a remarkable career in real estate development that spanned
15 six decades; and

16 WHEREAS, Mr. Sealy was a dynamic leader and
17 successful businessman, he was founder of the Sealy Company
18 that built and managed over 8500 apartment homes in four
19 states; he was also involved in the insurance, banking, and
20 environmental service industries; and

21 WHEREAS, Mr. Sealy, a visionary who became
22 well-known for his contribution to the development industry,
23 served as a charter member and as a National Director of the
24 Homebuilders of Tuscaloosa; he served as President and
25 National Director of the Alabama Real Estate Association; he

1 was instrumental in the formation of the Industrial
2 Development Authority; he was named Northport Outstanding
3 Business Leader in 2004, received the Pillars of West Alabama
4 Award in 2005, and the Tuscaloosa County High School
5 Outstanding Alumnus of the Year in 1989; and

6 WHEREAS, he leaves to mourn his death his beloved
7 wife of 63 years, Virginia Ray Sealy; a son, Charlie Sealy,
8 Jr., (Debra); daughter, Gina Sealy Miers; grandchildren,
9 Charlie O. Sealy III (Sasha), Jennifer Lamon Pass (Dave),
10 Christina Sealy and Maria Sealy; and.

11 WHEREAS, Mr. Sealy was a great Alabamian who
12 excelled in many fields through the years; he earned
13 widespread respect for his ranging capabilities and for his
14 significant contributions to the state; now therefore,

15 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
16 HOUSES THEREOF CONCURRING, That it is with profound sadness
17 that we record the death of Mr. Charlie Oliver Sealy, Sr., and
