3 COMMEMORATING THE 50TH ANNIVERSARY OF THE BRINDLEE
4 MOUNTAIN SADDLE CLUB.

6 WHEREAS, it is with great pride and pleasure that
7 the Alabama Legislature notes the 50th anniversary of the
8 Brindlee Mountain Saddle Club; and

9 WHEREAS, the Brindlee Mountain Saddle Club was first
10 formed in 1960 by horse enthusiasts in Alabama communities
11 such as Allens Crossroads, Oleander, and Union Grove; and

12 WHEREAS, the club, whose preamble is "To inculcate
13 and stimulate the love of horses and of the outdoors, we unite
14 to form the Brindlee Mountain Saddle Club," became officially
15 incorporated in 1966; and

16 WHEREAS, in 1989, the club purchased five acres of
17 land from Mr. Melvin H. Whisenant for \$1.00 and continues its
18 operations from that site today; and

19 WHEREAS, the club is very family oriented and has
20 several fourth generation members; it has evolved from a club
21 totally devoted to horses, horse shows, and trail rides, to
22 one that loves nothing more than to help the citizens of
23 Marshall and Morgan Counties; and

24 WHEREAS, acting with unselfishness and a love for
25 its fellowman, the club has expended thousands of dollars to

1 help the poor and unfortunate during Christmas and other times
2 of need; and

3 WHEREAS, the club's members work tirelessly all year
4 to ensure sufficient funds are available to help those in
5 need; the only thing asked of those receiving the club's
6 financial blessings is that they, when able, also help someone
7 in need; and

8 WHEREAS, in this Golden Anniversary year, accolades
9 are due to founding members: Melvin and Myra Whisenant, T. H.
10 "Butch" and Tommie Dunn, David and Mary Couch, J. B. and
11 Dorothy Clark, J. R. and Ruth Barclift, James "Redtop" Dunn,
12 Fred Daugette, and Troy Whisenant; in addition, special
13 recognition is due to the club's honorary lifetime members:
14 Myra Whisenant, Mac Thomas, James "Redtop" Dunn, Marvin Dunn,
15 David Couch, Dorothy Clark, Fred Daugette, and Torre
16 Alldredge; now therefore,

17 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
18 HOUSES THEREOF CONCURRING, That the Brindlee Mountain Saddle
19 Club is hereby recognized and commended for its good works and
