8 NAMING THE PORTION OF ALABAMA HIGHWAY 113 BETWEEN  
9 HIGHWAY 29/31 IN FLOMATON AND INTERSTATE 65 THE DEWEY J.  
10 BONDURANT, JR. HIGHWAY.

12 WHEREAS, in our desire to acknowledge and commend  
13 Alabamians of exceptional achievements, it is with sincere  
14 pride and admiration that we name a portion of Alabama Highway  
15 113 between Flomaton and Interstate 65 the Dewey J. Bondurant,  
16 Jr. Highway; and

17 WHEREAS, a joint project between the states of  
18 Alabama and Florida will provide 13.5 miles of four-lane  
19 divided highway between Highway 29/31 in Flomaton and Exit 69  
20 on Interstate 65; this project is the culmination of more than  
21 four decades of hard work between representatives of the two  
22 states who were seeking to establish a suitable hurricane  
23 evacuation route; and

24 WHEREAS, Mayor Dewey J. Bondurant, Jr., of Flomaton  
25 worked tirelessly to see this project come to fruition; the  
26 project would not have been possible without his hard work and

1 dedication; he is to be commended for seeing this effort  
2 through to conclusion; now therefore,

3                   BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
4 HOUSES THEREOF CONCURRING, That the portion of Alabama Highway  
5 113 between Highway 29/31 in Flomaton and Interstate 65 is  
6 hereby named the Dewey J. Bondurant, Jr. Highway and that the  
7 proper officials are requested to place and maintain markers  
8 designating the Dewey J. Bondurant, Jr., Highway as provided  
9 in this resolution.

10                  BE IT FURTHER RESOLVED, That a copy of this  
11 resolution be provided as a memento of this honorary  
12 designation by the Alabama Legislature.
