22 Vice President of the Mobile Division in 1998; and

24 and serves on the boards of Hancock Bank of Alabama, the
25 Industrial Park Board of Mobile County, the Infirmary Health
26 System, the Mobile Symphony, the National Maritime Museum of

1 the Gulf of Mexico, The Forum; she is past chair of the
2 Industrial Development Board of the City of Mobile, Leadership
3 Alabama, and the Mobile Area Chamber of Commerce, and serves
4 on the Executive Council of the Mitchell College of Business
5 at the University of South Alabama; and

6 WHEREAS, Mrs. Thompson has been particularly
7 recognized for her service to the Mobile Area Chamber of
8 Commerce; under her leadership, the Chamber began an
9 aggressive outreach program to encourage and support
10 minority-owned businesses; as a result of this program, Mobile
11 now has a federally funded Minority Business Enterprise
12 Center; and

13 WHEREAS, Mrs. Thompson's service to Alabama Power
14 Company and to the community reflects honor on her and on all
15 Alabamians; she and her husband, Jerry, are justly proud of
16 her many achievements; now therefore,
