9 WHEREAS, in our desire to acknowledge and commend  
10 Alabamians of exceptional achievements, it is with sincere  
11 pride and admiration that we name a portion of Alabama Highway  
12 113 between Flomaton and Interstate 65 the Dewey J. Bondurant,  
13 Jr. Highway; and

14 WHEREAS, a joint project between the states of  
15 Alabama and Florida will provide 13.5 miles of four-lane  
16 divided highway between Highway 29/31 in Flomaton and Exit 69  
17 on Interstate 65; this project is the culmination of more than  
18 four decades of hard work between representatives of the two  
19 states who were seeking to establish a suitable hurricane  
20 evacuation route; and

21 WHEREAS, Mayor Dewey J. Bondurant, Jr., of Flomaton  
22 worked tirelessly to see this project come to fruition; the  
23 project would not have been possible without his hard work and  
24 dedication; he is to be commended for seeing this effort  
25 through to conclusion; now therefore,

BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH HOUSES THEREOF CONCURRING, That the portion of Alabama Highway 113 between Highway 29/31 in Flomaton and Interstate 65 is hereby named the Dewey J. Bondurant, Jr. Highway and that the proper officials are requested to place and maintain markers designating the Dewey J. Bondurant, Jr. Highway as provided in this resolution.
