2 son, Lev (LaShaunda) Holly, Sr.; mother, Lillian Lucille Bush
3 Holly; sisters, Karen Smith and Sheryl (Lessie) Whitmore;

5 B. Holly; Howard Mitchell, and John James; one godson,
6 Legarion Phelon; and a number of additional caring relatives

9 the community whose presence will be greatly missed by those
10 who were privileged to know her during the short span of her
