4 6A FOOTBALL CHAMPIONSHIP.

7 the State 6A Championship on December 4, 2009, defeating
8 Prattville High School in the finals by a score of 28-23
9 before an enthusiastic crowd at Bryant-Denny Stadium at The
10 University of Alabama; and

12 Hoover High School Football in this decade and makes the
13 Hoover Buccaneers the Class 6A "Winningest Team of the
14 Decade"; and
