8 COMMENDING MR. J. SMTIH LANIER, II, ON RECEIVING THE
9 2010 BOY SCOUT DISTINGUISHED CITIZEN AWARD.

11 WHEREAS, it is a pleasure to extend commendations
12 and congratulations to Mr. J. Smith Lanier, II, on the
13 occasion of receiving the 2010 George H. Lanier Boy Scout
14 Distinguished Citizen Award; and

15 WHEREAS, he is a highly esteemed businessman and
16 civic leader whose community contributions are numerous and
17 far-reaching, and he will be recognized at the Distinguished
18 Citizen Award Dinner on March 11, 2010, at the Valley
19 Community Center; and

20 WHEREAS, Mr. Lanier is an alumnus of Auburn
21 University, where he was a member of Sigma Nu Fraternity; he
22 graduated from the United States Merchant Marine Academy
23 (USMMA), obtaining a degree in Mechanical Engineering and a
24 commission in the United States Navy, and he served two years
25 of active duty during the Korean War; and

26 WHEREAS, he currently holds the office of Chairman
27 Emeritus of J. Smith Lanier & Company, which is nationally

1 recognized as one of the oldest and largest insurance
2 brokerage firms in the United States; Mr. Lanier has assisted
3 in launching many additional business ventures in various
4 industries and was a founding director of five publicly
5 trading companies; and

6 WHEREAS, a strong advocate for education at all
7 levels, he was a founder of Springwood School in Lanett,
8 Alabama, and has served on several boards of trustees,
9 including the USMMA, LaGrange College, Oglethorpe University,
10 and Atlanta Christian College; and

11 WHEREAS, he has been a generous supporter and has
12 served Auburn University in many capacities, including being
13 the first Dean's Advisory Board Chair of the College of Human
14 Sciences; he also served on the Auburn University Foundation
15 Board; in December 2000, the university honored Mr. Lanier
16 with the International Quality of Life Award at the United
17 Nations; a devoted family man, he and his wife, Elizabeth
18 "Betty" Walker Lanier, have three daughters who are Auburn
19 University alumnae and eight grandchildren, one of whom is
20 currently a student at Auburn; and

21 WHEREAS, through the years, Mr. Lanier has been
22 active in the political arena, having served as a county
23 chairman and on the state executive committee of the Alabama
24 Republican Party; he was a presidential elector from Alabama
25 in 1964 and a delegate to two Republican National Conventions;

1 WHEREAS, among his many community contributions, Mr.
2 Lanier was a leader of a campaign to raise \$9.6 million to
3 build a state-of-the-art Center for Therapeutic Recreation at
4 Roosevelt Warm Springs Institute for Rehabilitation; Mr.
5 Lanier has been recognized with many awards including National
6 Small Business Person of the Year; the USMMA selected him as
7 Alumnus of the Year in 1998, and he was inducted as the 28th
8 member of the Distinguished Hall of Graduates in October 2009;

10 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF
11 THE LEGISLATURE OF ALABAMA, That in recognition of his many
12 achievements and dedicated service to his fellowman, Mr. J.
13 Smith Lanier, II, is honored and commended, and this
