8 Board, the Etowah County Historical Society, Riverfest, and
9 the Keep Etowah Beautiful Executive Committee, along with the
10 Renew Our Rivers initiative; and

11 WHEREAS, a man of keen intellect, he has been a
12 lifelong learner, earning a law degree along the way that has
13 served him well in both his career and civic involvement; his
14 contributions to his fellowman are far-reaching and
15 innumerable, and over the span of almost four decades, he has
16 had a positive impact on many lives; Mr. Maise will be greatly
17 missed by colleagues in the workplace, but he will remain an
18 integral part of the life of his beloved city; now therefore,
