9 TEST MARKET FOR GOOGLE'S ULTRAFAST BROADBAND NETWORK.

11 WHEREAS, it is with great pride and pleasure that  
12 Huntsville is commended for its dedicated, concerted efforts  
13 to become a test market for Google's new ultrafast broadband  
14 network, Google Fiber; and

15 WHEREAS, Huntsville's high-tech population makes it  
16 an ideal place to test the new fiber optics network that  
17 promises Internet connection speeds one hundred times faster  
18 than currently available to most homes; Google Fiber would  
19 have download speeds up to one gigabit per second; and
