12 received of the untimely death of Commissioner Charlie
13 McCorvey, Jr., of Peterman, Alabama, on February 24, 2010, at
14 the age of 59 years; and

15 WHEREAS, he was a prominent and effective civic
16 leader, faithfully serving the people of District 4 with honor
17 and distinction on the Monroe County Commission; and

18 WHEREAS, Commissioner McCorvey was instrumental in
19 attaining the paving of dirt roads in the rural areas of
20 northern Monroe County; and

21 WHEREAS, he was actively involved in his district,
22 giving generously of his time, resources, and wisdom; and

23 WHEREAS, among his civic contributions, he served
24 conscientiously on numerous boards, ably representing Monroe
25 County, including the Community Action Board, the Monroe
26 County Animal Shelter, and the Association of County
27 Commissioners of Alabama; and

2 role in securing medical insurance for county employees and
3 their families; and

4 WHEREAS, through the years, he earned widespread
5 respect for his exceptional abilities and tireless commitment
