3           COMMENDING MOBILE OFFICER BRANDON NYKORI SIGLER AS A  
4 POSTHUMOUS NOMINEE FOR THE 2010 LEGISLATIVE MEDAL OF HONOR FOR  
5 LAW ENFORCEMENT.

7           WHEREAS, it is with highest commendation that we  
8 recognize Mobile Police Officer Brandon Nykori Sigler as a  
9 posthumous nominee for the 2010 Legislative Medal of Honor for  
10 Law Enforcement, the state's highest law enforcement award for  
11 extraordinary courage in the line of duty; and

12           WHEREAS, in June 2009, Officer Sigler responded to a  
13 call for service at Tyler Ridge Apartments in Mobile; he was  
14 off-duty at the time, serving the complex as a courtesy  
15 officer; upon arriving at the scene of a chaotic disturbance,  
16 Officer Sigler intervened in an attempt to keep the peace and  
17 restore order; after Officer Sigler had successfully calmed  
18 one hostile situation, another disturbance erupted and when  
19 Officer Sigler took immediate action and intervened a second  
20 time to safeguard residents, he was fatally wounded by  
21 gunfire; the cowardly murderer fled the scene but was  
22 apprehended a short time later; and

23           WHEREAS, Officer Sigler made the ultimate sacrifice,  
24 giving his life to protect the citizens he so proudly served,

1       and his heroism reflects great credit upon the Mobile Police  
2       Department and the noble profession of law enforcement; and

3               WHEREAS, Officer Sigler was a worthy exemplar of  
4       those caring and dedicated men and women who stand ever ready  
5       to provide prompt and professional response in times of  
6       crisis, and he is highly deserving of this posthumous  
7       nomination for the Legislative Medal of Honor; now therefore,

8               BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
9       HOUSES THEREOF CONCURRING, That we hereby recognize and honor  
10      Mobile Police Officer Brandon Nykori Sigler as a posthumous  
11      nominee for the 2010 Legislative Medal of Honor for Law  
12      Enforcement and direct that his family receive a copy of this  
13      resolution as a token of our admiration and esteem.
