9 ACHIEVEMENT.

11 WHEREAS, it is with great appreciation that we
12 recognize the remarkable personal and professional
13 achievements of Mrs. Margene Hudson; and

14 WHEREAS, Mrs. Hudson was born and reared in the
15 Moores Mill Community; she graduated Salutatorian of her class
16 from Hazel Green High School, where she served as Secretary of
17 her class and as a cheerleader; her dedication and community
18 spirit were rewarded with the American Legion Award for
19 Academic Accomplishment and the Kiwanis Award for Good
20 Citizenship; and

21 WHEREAS, on November 1, 1950, Mrs. Hudson accepted a
22 position with First National Bank (later Regions Bank), where
23 she served for 50 years, becoming the bank's first female
24 assistant vice president and later its first female vice
25 president; she was very active in the National Association of
26 Bank Women, where she held each state office, as well as

1 numerous boards and committees, over the course of her
2 membership; and

3 WHEREAS, always active in the community, Mrs. Hudson
4 served on the original Committee of Central City Pacesetters,
5 where she was frequently called upon to host important events;
6 she also served as Secretary of the JCC Committee and on the
7 Education Committee for Limestone Correctional Facility; Mrs.
8 Hudson is a committed Christian and has been an active member
9 of Flint River Baptist Church and, more recently, First
10 Baptist Church of Meridianville; and

11 WHEREAS, Mrs. Hudson married Ernest Hudson in 1951
12 and the union bore one child, Russell Allen Hudson; Russell
13 Allen Hudson and his wife, Malissa, have two children, Kylie
14 and Taylor; Mrs. Margene Hudson is finally leaving her
15 lifelong home in North Alabama to spend time with her son,
16 daughter-in-law, and grandchildren in Texas; we are honored by
17 the opportunity to congratulate her on a lifetime of service
18 to her community and our state; now therefore,
